#### General clauses:-

#### Party number 1 will

1. Permit to run AutoCAD 2D, AutoCAD 3D, Sketchup & Revit Architecture programs for first, second and third year students of Bachelor of Interior Design during their entire academic period.

2. Provide requisite infrastructure to conduct the course including classrooms, computers, internet, projector and other utilities.

3. Register students in course by providing adequate information in batch size of 30 students.

4. Ensure that all the participating students attend classes regularly as per the schedule.

5. Both the parties will not hire employees of each other directly or indirectly during & up to three years till the execution of this agreement.

6. Duration of classes shall be for a minimum period of 2 hours per day.

7. The payment to the party number 2 will be made in two phases. 1<sup>st</sup> payment will be made on or before 31<sup>st</sup> of October & 2<sup>nd</sup> payment will be made on or before 28<sup>th</sup> of February every year.

8. Part number 2 shall conduct AutoCAD (Level 3) regular course for 3<sup>rd</sup> year students without any additional cost.

#### Party Number 2

- 1. Shall conduct AutoCAD 2D, AutoCAD 3D, Sketchup & Revit Architecture classes for first, second and third year students of Bachelor of Interior Design
- 2. Provide faculty with requisite knowledge and experience for undertaking training program. Astral will provide substitute faculty as and when required for uninterrupted training.
- 3. Provide Autodesk Course Completion Certificate for training on AutoCAD and Revit Architecture.
- 4. Provide Course Completion Certificate for Certificate course in Sketch up signed jointly by the representatives of party no 1 and 2.

5. Get software for non-commercial / academic usage for students as well as college.

6. Provide free of cost training to students from financially weak back ground of the college on need basis as referred by party no.1 (Limited to 10% of the total paid students)

7. Provide free maintenance services of computers at the lab for conducting the training program. Spares if required will be paid extra as per actual by party number 1.

8. Fees amount collected will be shared with the college as per Annexure II & III.

9. Provide training to students for specific number of hours as per Annexure I.

10. Any dispute or differences arising out of this MOU shall be tried only by the courts at Nagpur and the Nagpur courts shall have exclusive jurisdiction to deal with the said differences or disputes.

The duration of this agreement shall be for a period of 3 years from the date of signing ------24 Augur 2022 and if not renewed or amended in writing, the same will be continued as expired and/or terminated (w.e.f. 1<sup>st</sup> July 2022 to 30 June 2025).



#### Terms and Conditions:

- 1) LAD will take initiative to form ELC in college and run as per give SoP.
- Setting up "LAD-ELC" comprise of Executive committee including Nodal Officer (NO), Convener (Campus Ambassador-CA), President, Vice-President and the class representative.
- 3) Convener (Campus Ambassador) will be the student representative of LAD, DEO, Nagpur and WEF will give them internship duration of 06 months. Based

- LAD, NO and CA will ensure to enrol 100% students as a voter through voter registration app
- 6) On the basis of the activities/ events/ programs and Voter Registration Drive LAD will get a nomination for district level award and then state level award.
- 7) LAD has to extend full cooperation in helping WEF interact with the students. If a training or event or project is planned by WEF, then LAD will make available appropriate space, volunteers, and participants.
- LAD has to extend full cooperation for displaying ELC Wall and the certificate given to college.
- 9) WEF and LAD show readiness to work out several beneficial projects for generating citizen's awareness and for the betterment of society.
- 10) The LAD will need to submit all activity documents viz voter registration drive, voter awareness camp to WEF, and then WEF will submit the collected consolidated data to DEO, Nagpur.
- 11) This MOU shall be valid for the college year 2023-24, commencing on 1st September 2023.

#### **Breach of this MOU**

In the event of any breach of the terms of this MOU, which is capable of rectification, by (Party DEO office and WEF) either party hereto, other party shall be entitled to call upon the party to rectify such breach within one month from the date of notice, failing which the breach shall be deemed to be a material breach, and shall entitle such other party to rescind this MOU for material breach.



#### Article 2

Both sides shall endeavour to favour, as far as their financial means allow:

- Exchange of faculty members and research associates.
- Organisation of joint educational activities like student exchange programmes, workshops and symposia.
- Other forms of cooperation made by mutual agreement.

#### Article 3

 In case finances are required for joint programmes they shall be shared by both the institutions in proportion to the number of participants of the programme. The expenditure required for students of party no 1 will be borne by party no 1 and the expenses required for students of party 2 will be borne by party no 2. Finances may be raised for the joint organization of activities like student and faculty exchange programmes and workshops etc. (if required)

#### Article 4

This memorandum of understanding shall become effective from the date of its signing on  $\frac{12 09 2023}{109 2023}$  by representatives of both institution and same shall remain effective for 5 (five) yearsup to  $\frac{11 09 2028}{2028}$ . The MOU can be extended by the written mutual consent. Either side may terminate this agreement at any time by giving a written notice in 6 (six) months advance to the other institution.

#### Article 5

Any dispute arising out of the violation of terms of this MoU are in connection with this MoU between the parties and shall be resolved by mutual negotiation. In case of any unresolved dispute, the parties shall refer the said dispute for arbitration by the sole
